For Rwanda DHS 2019-2020, the (unweighted) tabulation of variable 'v044' gives the number of women who were selected and actually interviewed for 'Domestic Violence' module were 2,788. For the variable 'd105a' (ever been pushed etc. by husband/partner) 841 records are coded as missing (.) i.e. these women were never in an intimate relationship with men. Hence, the number of women who were never in an intimate relationship with men were 841 and there were 1,947 women who were and answered questions pertaining to intimate partner violence. However, for the variable 'v701' (husband/partners education level) 1,122 records are coded as missing (.). So there were 281 records for which husband/partners education level is missing, is that correct? Thanks

A dot (.) in Stata means Not Applicable, or NA. It does not mean "missing", as in No Response or NR. With very few exceptions, the only time a case has a dot is when the question was not asked, because the response to some earlier question(s) made them ineligible for the question.
