Consent statements are printed in the questionnaires, in the survey final reports in an Appendix. See the Tanzania final report Appendix E for the questionnaires. The consent statement on the first page of the Woman's Questionnaire requests the woman's consent for the individual interview, which includes the domestic violence module. See also questions/statements within the Domestic Violence module itself (Qs. 1401, 1401A, and the statement prior to Q. 1431).
