I am trying to find out the mechanism for sample selection for women for the domestic violence module in Colombia surveys. I remember reading a footnote somewhere reading Colombia is an exception to the usual DHS method of selecting women for the domestic violence module (since in Colombia, all eligible women in a household are surveyed whereas the usual is one eligible woman per household). I am unable to find documentation in English which mentions the sample selection of women within the household for this module. It would be great if I could get help with this. Thanks!

I would also check chapter 1 which sometimes has information on general sampling procedures for what is covered in the questionnaires. You may also want to check the chapter dedicated to domestic violence and finally the questionnaires. They are in Spanish. In the meantime, I will check with those who worked on the survey to find out what I can. Thank you!
